BUILDING INTERNATIONAL RELATIONS

In a significant step towards fostering bilateral cooperation, the Customs Authority recently facilitated the participation of twenty-five staff members in a comprehensive Basic Customs Training Course. The initiative, which took place at the Directorate General of Customs and Excise (DGCE) Education and Training Center (Pusdiklat) in Jakarta, was carried out under the MoU signed between the two

Each participant had an opportunity to speak for 2 minutes about the specific topic given by the $\ensuremath{\mbox{\sc the}}$ facilitator. Participants expressed that they enjoyed the session where topics were chosen randomly from a keyword list. They indicated they felt a bit nervous initially, because they had short time to to prepare them for the unexpected.

The facilitator and the DCOP, Mr. Sergio Riveros encouraged the participants to 'always be pre-pared for an unexpected situation', particularly in public speaking-related skills as they may be asked to do so in a particular meeting'.

From 15-22 April 2023, CA Commissioner and Coordinator, Institutional Relations and Communication and representatives from Ministry of Tourism, Commerce and Industry (MTCI) went to Geneva for a special mission on Timor-Leste Accession to the World Trade Organizations (WTO). The team met and reviewed agreement content and signed pending agreements with WTO members and discussed further meeting plans to finalize the agreement signing issues with the remaining WTO members

The next 6th Working Party meeting will be held in September 2023 and hopefully Timor-Leste will become member of WTO during the 13th Ministerial Conference (MCI3) meeting in February 2024. The Working Party members appreciated the efforts made by Timor-Leste and offered training opportunities to accelerate the WTO accession process.

The meeting was chaired by Timor-Leste's Coordinating Minister for Economic Affairs (MCAE) Mr. Joaquim Amaral.

IMPLEMENTATION OF THE ELECTRONIC **DECLARATION (E-DECLARATION) FOR** PASSENGERS IN AIRPORT AND BORDER

On May 1st, 2023, the Timor-Leste Customs Authority started implementing passengers' Electronic Declaration launched online for passengers who enter Timor-Leste through President Nicolau Lobato, International Airport and the border areas of Batugade and Suai.

Mr. Zeca Amaral, the Coordinator of CA Informatics and Statistic Unit, said, it was a success for Customs

to start transforming everything electronically.

"We need to ensure that paperless strategy must continue to be developed and implemented at Customs so as to sequence time, and make everything technically organized." he said.
