## INTERNAL CAPACITY BUILDING.

During the month of October and November 2023, the CA Gender Focal point and HR Coordinator facilitated two days training on "No To Sexual Harassment " to CA staff at border area" Batugade" and Suai Salele. As part of the gender equality and sexual harassment awareness raising within Customs authority staff, this activity has been taking place in all CA offices in Dili in the past few months, including in the border areas where CA staff are working at the moment.

The initiative of sharing sexual harassment awareness within the Customs authority was also supported by the

government through the Civil Service Commission in early February this year for further implementation within CA.

The training took place in Batugade-Maliana from 17-18 October 2023 with a total of 11 participants (8 men and 3 women) and in Suai -Salele on 20 Nov 2023 with a total of 8 participants (all men).

In addition, CA HR Coordinator Mrs. Marlena de Carvalho and the CA Gender Focal Point Mrs. Rosa Cruz, also informed about relevant administrative and public servants' laws as per Civil Service Commission rules and regulations applied to public servants in Timor-Leste.

### **BUILDING INTERNATIONAL RELATIONS**

As a continuous collaborations towards fostering bilateral cooperation and capacity building, a group of CA management team attended 6 days training in Pusdiklat, Regional Training Center, Jakarta, Indonesia.

The training started from 06 -11 November 2023 that composed of 14 participants, 10 males and 4 females. The topics covered during the training were "Customs Modernization, Customs Reform Initiative, Risk Management in Customs Context and some site visits during the one week period.

At the end of the sessions, they were given a task to prepare a paper work that contains questions on future challenges, implementing steps, possible solutions and recommendations for further improvement.

among others were Customs Broker Licensing Operations Rules and introduction on the existence of Border Management Committee (BMC) to support trade related activities at Border areas.

CTCC members shared their thoughts on the topics discussed and raised questions to relevant CA staff for proper answers.

In addition, the meeting minutes was also shared with all relevant CTCC permanent members for their reference in the next meetings to come.
